#### I. TFS & MFS - F&I Sentinel

F&I Sentinel will begin reviewing Key fob service contract for approval for funding.

DEADLINE: May 1, 2023 January 1, 2024

#### II. Nissan Motor Acceptance Corp (NMAC) – F&I Sentinel

F&I Sentinel will begin reviewing VPP (product warranties) and EWU (Excess Wear & Use waivers).

DEADLINE: November 17, 2023 January 3, 2024

PRODUCT(S): VPP (product warranties) and EWU (excess wear and use waivers)

## III. Ford Motor Credit Corp (FMCC) (UPDATE)

May 26, 2023 - GAP Administrators received new guidelines for GAP waivers:

- 1. GAP waivers may not exclude waivers with deferred first payments
- 2. GAP waivers must allow for variable payment schedules. (i.e., cannot require a "uniform" payment schedule)

DEADLINE: Unknown. Waiting for further communication from FMCC. December 31, 2023

## IV. Nissan Motor Acceptance Corp (NMAC) – F&I Sentinel

F&I Sentinel will begin reviewing Motor Club product forms.

DEADLINE: January 3, 2024

#### VI. Bass Pro Shops Financial Services (BPSFS) - F&I Sentinel

We received notice from F&I Sentinel that BPSFS has been added to the FIS portal. It is not yet open for submissions. Per FIS, it is expected the approval requirements will only apply to GAP waivers on service contracts covering Marine, ATV's, and trailers for these products.

DEADLINE: Unknown
